

SUPPLEMENTARY CHARGES RELATED TO ADDITIONAL BURDENS OF GAS SYSTEM

YEAR 2019

The Regulatory Authority for Energy, Networks and the Environment (ARERA) has introduced supplementary charges to the transmission tariff to be paid by transmission users, in order to cover general burdens of gas system.

The supplementary charges currently in force applied as an increase of the unitary commodity charge CV to the volumes injected into the national transmission network, with the exception of storage system, are:

- a) Tariff component ϕ expressed in Euro/ Sm³, to cover the imbalances of the revenues repartition mechanism related to the capacity charge CRr, according to comma 15 of RTTG¹;
- b) Unitary commodity charges CV^{FG}, expressed in Euro/ Sm³, to cover the guarantee factor of revenues for regassification service, according to comma 18 of Delibera ARG/gas n. 92/08 of AEEG;

The supplementary charges currently in force applied to the volumes drawn at redelivery points are:

- c) Tariff component S_D , with negative sign and expressed in Euro/ Sm³, to ensure the economic invariance of what provided for legislative Decree n. 130/10 and applied to final customers connected to distribution network;
- d) Tariff component GS_T , expressed in Euro/ Sm³, to cover the compensation of tariff facilitation for gas customers in state of unease, according to comma 4 of Delibera ARG/gas n. 93/10 of AEEG and applied to direct final customers connected to regional network;
- e) Tariff component RE_T , expressed in Euro/ Sm³, to cover the burdens for energy saving and for development of renewable sources in the system gas, according to comma 4 of Delibera ARG/gas n. 93/10 of AEEG and applied to direct final customers connected to regional network.
- f) Tariff component UG_{3T} , expressed in Euro/ Sm³, to cover non-payment of the amounts recognized supplier's transient, according to Article 3 of Delibera 363/2012/R/GAS of AEEG and applied to direct final customers connected to regional network.

From 1st October 2015 Regulatory Authority for Energy, Networks and the Environment has introduced supplementary charges to the transmission tariff applied to the volumes drawn at redelivery points, replacing the same components (CV^I, CV^{OS}, CV^{BIL}) applied to the volumes injected into the national transmission network

- g) Unitary commodity charges CRV^I , expressed in Euro/ Sm³, to cover gas consumption containment, according to comma 3 of Delibera n. 277/07 of AEEG;

- h) Unitary commodity charges **CRV^{OS}**, expressed in Euro/ Sm³, to cover the guarantee factor of revenues for storage service, according to comma 10bis of Delibera ARG/gas n. 29/11 of AEEG, and the expenses sustained by the GSE for what indicated by commas 9 and 10 of Legislative Decree n. 130/10;
- i) Unitary commodity charges **CRV^{BL}**, expressed in Euro/ Sm³, to cover the burdens related to the gas balancing system, according to comma 10 of Delibera ARG/gas n. 155/11 of AEEG;

With Delibera from 23 November 2017 No. 782/2017/R/GAS, the Authority has introduced a new additional component of the transport tariff, **CRVST** expressed in Euro/ Sm³, to cover the burdens deriving from the new regulation of the “*settlement gas*”, applied to final customers connected to distribution network.

The aforementioned supplementary charges are defined at the beginning of every quarter by Delibera of ARERA published in ARERA web-site.
